NOTIFICATION

As per extant procedure, pensioners/ family pensioners are required to appear in person at Treasury Offices in November every year for continuity of pension/ family pension. In order to simplify the process of securing life certificate and for the welfare of the old aged/ infirmed persons, the Prime Minister, Shri Narendra Modi launched "Jeevan Pramaan" – an "Aadhar-based Digital Life Certificate" for pensioners that will push towards self-certification.

The proposed digital certification will do away with the requirement of a pensioner having to submit a physical Life Certificate in November each year unless they chose otherwise. The Department of Electronics and IT has developed a software application which will enable the recording of the pensioner's Aadhar number and biometric details from his mobile device or computer with the aid of a biometric reading device. Key details of the pensioner, including date, time, and biometric information will be uploaded to a central database on real-time basis, ultimately enabling the Pension Disbursing Agency to access a Digital Life Certificate. This will conclusively establish that the pensioner is alive at the time of authentication.

It is hereby notified to all concerned stakeholders that the Governor of Mizoram is pleased to recognise the Digital Life Certificate obtained/ furnished through Jeevan Praaman Portal with effect from 15th September, 2015 in respect of pensioners/ family pensioners of the State Government.

All pensioners/ family pensioners who possess Aadhar Card are requested to approach their nearest Common Service Centres (CSCs) or Mizoram Civil Pensioners' Association, General Headquarters, Aizawl where such biometric reading devices are installed, for enrolment, etc.
