The Empanelment Board for Selection of Consultancy Firms, Government of Mizoram invites Expression of Interest (EOI) for empanelment/short-listing of consultants/ consulting firms for the following categories –

- 2) Project Development & Construction works, and
- 3) Information Communication Technology/IT including software development.

Interested consultants/firms who wish to be empanelled are required to submit their comprehensive profile in the prescribed format which can be downloaded from the Department's website [www.mizofin.nic.in](http://www.mizofin.nic.in) or obtained from Establishment Branch of Finance Department during office hours on all working days.

The Expression of Interest (EOI) should be accompanied by application fee of ₹ 2000/- (Rupees two thousand) in the form of DD/Challan in favour of Secretary, Finance Department, Government of Mizoram payable at Aizawl.

Sealed EOI should be clearly marked on top of the envelope "**Expression of Interest for Empanelment of Consultants**". Further, the area of specialization in which the firm wishes to be empanelled should be clearly indicated in the envelope bearing the Expression of Interest and if the firm wishes to be empanelled in more than one area of specialization, it should be submitted separately. The filled up format of Expression of Interest should reach to the Finance Commissioner on or before **1:00 PM on May 15<sup>th</sup>, 2016.**
